PLAYER'S CHOICE RULES OF PLAY



TOURNAMENT RULES

Player Declaration: By entering into the monthly Player's Choice Handicapping Tournament, each player declares the following: "In consideration of my being allowed to participate in this Tournament, I do hereby irrevocably authorize Assiniboia Downs or its licensees to print, publish, televise or otherwise distribute and use photographs or likenesses of me. In addition, I do declare that I am at least 18 years of age at the time of entry".

- Contestants use their paid in advance \$60 bankroll in their assigned "PERSONAL" HPI account to make a \$2 WPS bet on ONE horse in 10 different races for the contest. For contest purposes, all North American thoroughbred, harness and quarter horse tracks on the designated contest date will be considered an eligible contest race. Your ten contest wagers must be placed by 11:00 p.m. (central) on the contest day.
- Contestants may place ANY OTHER WAGERS they wish to place on their PERSONAL HPI account as well. The FIRST 10 \$2 WPS wagers placed on your HPI account on the contest date will be considered your wagers for the contest.
- 3. Wagers can be cancelled for the Player's Choice Handicapping Tournament. All contest monies must be wagered within the time limit of the contest. There is a 20 to 1 cap on the win wager (\$42.00 maximum payoff), 10 to 1 cap on the place wager (\$22.00 maximum payoff) and 5-1 cap on the show wager (\$12 maximum payoff). The caps are for contest purposes only.
- 4. If a horse that you have wagered on is scratched or your wager is refunded, you must place another contest wager.
- 5. It is the participants responsibility to make sure that their 10 WPS wagers are placed prior to 11:00 p.m. (central)
- 6. Participants \$60 advance paid bankrolls will be deposited by Assiniboia Downs into their personal HPI accounts for contest purposes.
- 7. Participants winnings from the contest will remain in your personal HPI account.

- 8. The winner will be determined by the total combined mutuels of their wagers. In the event of a tie, the contestant with the greater number of winners on the card will be declared the winner. In the further event of a tie, the Manitoba Jockey Club has the sole right to break any tie by randomly drawing from the qualified entries.
- 9. The preliminary results of the contest will be emailed by the Tuesday following the tournament. Once the preliminary results have been reviewed, the contest will be made official.
- 10. PRIZE MONEY: 1st \$1,000 (plus a trophy), 2nd \$400, 3rd \$200, 4th \$100, 5th \$50
- 11. POINTS AWARDED: All contestants will also be awarded points toward being named the Handicapper of the Year. The Handicapper of the Year is based on your best seven of 12 tournaments. Prize money for Handicapper of the Year. 1st Trip for two to Las Vegas (the winner will receive \$3,500 to book their trip), 2nd \$500, 3rd \$250.
- 12. Each player agrees to abide by all published tournament rules and regulations. In the event of a dispute, the contest coordinator of the tournament will render a decision. All players agree that the decision of the contest coordinator is final. The contest coordinator has the right to disqualify any tournament entrant who has violated any of the rules and regulations. Assiniboia Downs reserves the right to add, delete, amend, or change any portion of the tournament rules and regulations. No discussion or correspondence will be entered into concerning the contest.
- 13. All decisions by the contest coordinator(s) are final.
